Your Eminence, Forgive and Bless!

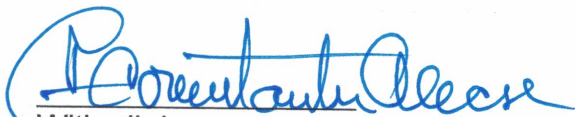

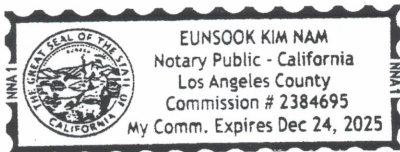
